

**** Pharmacy Provider Notice #292 – Lidocaine Patch PDL Update ****

February 2nd, 2023

Please be advised, the Department for Medicaid Services (DMS) is moving generic lidocaine 5% patches to preferred status on the Preferred Drug List (PDL). This change is due to the potential for shortages because of name brand Lidoderm 5% patch being discontinued.

On February 3rd, 2023 lidocaine 5% patch products will become preferred on the PDL (Examples listed below):
