Subject: Impact of 2026 WAC Price Decreases

Status: The Commonwealth of Kentucky Department of Medicaid Services (DMS) and MedImpact recognize that manufacturers of certain drugs subject to 2026 Medicare Maximum Fair Prices (MFP) has implemented Wholesale Acquisition Cost (WAC) reductions as of January 1, 2026. These changes may impact pharmacy providers. The National Community Pharmacists Association (NCPA) has released a statement with the following emphasis:

NCPA expects significant WAC price decreases beginning December 2025 and continuing into February 2026. Pharmacies are encouraged to monitor manufacturer and wholesaler announcements closely while proactively managing inventory for potentially affected products.
